With more than 30 years of experience, McAlester Regional Health Center's Infusion Department offers the only PICC team in the area, along with outpatient and inpatient infusion services.

Mike Noel, Bonnie Curry and Heidi McAlester, all Registered Nurses, staff the department, which includes 4 rooms for outpatient infusion, as well as PICC line insertions both for inpatients and outpatients.

Infusion patients include those with antibiotic therapies, blood transfusions or other extended IV treatments. And PICC lines are for long-term IV access and require specialized nursing skills for insertion.

MRHC opioid program gets national attention!

A program developed at McAlester Regional Health Center is getting national attention for its success reducing the use of addictive medication to treat patients.

The MRHC HOMES (Hospital Opioids Maintenance of Efficacy & Safety) program is being shared with hospitals across Oklahoma, and across the country.

We reduced the amount of opioids prescribed

by 30.3 percent (Daily Morphine Milligram Equivalents) during the first year of the program, in 2016. The program is also credited with a 15 percent decrease in the time patients spend in the hospital, a 16 percent reduction in patient falls, and a 28 percent drop in Adverse Drug Events.

AirCare now carries O-neg blood

McAlester Regional Health Center's dedicated air transport program is now approved to carry life-saving blood supplies for patients who may need it while in transit.

McAlester Regional AirCare worked with Oklahoma Blood Institute on the project, which includes use of an insulated thermal cooler in the AirCare helicopter at MRHC. The cooler contains 0-negative whole blood, which means medics can immediately administer blood to patients in an emergency, regardless of the patient's blood type.

The OBI is the exclusive supplier of blood supplies at MRHC.

"We are proud that our partners have added this life-saving feature for patients who need transfusions while on their way to us," said MRHC CEO David Keith. "When every second counts, AirCare medics will now be able to begin treatment in the field or in flight."

The thermal cooler maintains an appropriate temperature with a monitoring device. If the supply is not used within a prescribed timeframe, it is cycled back to OBI for inspection.

From the CEO: State funding for healthcare

The Oklahoma Health Care
Authority is closely guarding

Disabled. The OHCA must offer
at least two MCOs and may
contract with more. So how will
this impact Oklahoma patients,
hospitals, and MRHC?

The OHCA released "draft" permember, per-month capitated rates in January that bidders used for their proposals. The final rates paid to MCOs will be based on claims expenses that not yet available, but the same methodology will be used. Some commented that the rates were very low, and were concerned about significant reductions assumed. For example, the state's actuary assumed a 45% inpatient and ER usage reduction for disabled children!

While the SoonerHealth+



program is intended to be budget-neutral, OHCA asked for \$53 million in start-up costs. Of this, \$46 million is needed to handle a "claims bubble" – the overlap of upfront capitation payments to the MCO plans while the state pays incurred claims for these members. What is the "bubble" estimate for the third year of the program, when Aged, Blind and Disabled members in nursing homes join SoonerHealth+?

States are not allowed to directly supplement payments made by Medicaid MCOs, so Supplemental Hospital Offset Payment Program (SHOPP) will be reduced in size as SoonerHealth+ claims are paid by the MCO's. The OHCA estimates SHOPP reductions of \$69 million the first year, increasing as members in long-term care are added in subsequent years.

For now, hospitals and state officials are consulting with other states and technical experts to find a way of keeping the level of payment provided by SHOPP for hospital services delivered through SoonerHealth+.
